



## PAYMENT SELECTION INFORMATION

There are three options for tuition payment: **Annually, Semi-Annually, and Monthly.**

If you choose to pay ANNUALLY:

- **7% Discount Available:** To receive a 7% discount on base tuition, your payment must be received no later than May 18<sup>th</sup>, 2010. *This discount does not apply to additional electives.*
- **3% Discount Available:** To receive a 3% discount on base tuition, your payment must be received no later than July 1<sup>st</sup>, 2010. This discount is in lieu of, not in addition to, the 7% discount referenced above. *This discount does not apply to additional electives.*
- **Payment Methods:** Payment can be made by check, credit card or bank debit.

If you choose to pay SEMI-ANNUALLY:

- **Discount Available:** You are eligible for a 2% discount on base tuition. To receive this discount, your first payment must be received no later than July 1<sup>st</sup>, 2010. Your second installment must be received no later than January 10<sup>th</sup>, 2010. *This discount does not apply to additional electives.*
- **Payment Methods:** Payment can be made by check, credit card or bank debit.

If you choose to pay MONTHLY:

- **Payment Methods:** Payment can be made by credit card or bank debit. **No monthly check payments will be accepted.** Monthly payments will be spread over 10 months (August – May).

### CREDIT/DEBIT CARD USAGE:

Our published tuition rates include a 7% discount for payment via the cash equivalent method of bank debits. If you choose to use a credit or debit card for tuition payments, your fees will be 7% higher than the published rates.

### FINANCIAL AGREEMENT WITH PACES' PAIDEIA CLASSICAL EDUCATION PROGRAM

*This is a partial excerpt from the financial articles that are stated and agreed to on the Philosophy and Policy*

1. Registration fee is non-refundable.
2. **I understand that the overhead expenses of the school do not diminish with the departure of some students during the course of a semester. I understand that my obligation to pay the fees for the first semester is unconditional after the first day of classes. Further, I understand that my obligation for second semester fees are unconditional unless I give notice, no later than December 1st of the fall semester, of my intent to withdraw prior to inception of the second semester.**
3. If withdrawal during a semester is due to unusual hardship, such as employment transfer or illness, you may apply for a partial forbearance of the semester's tuition obligation.
4. A fee of \$50 will be charged for any class changes after the first two weeks of school.
